




DESCRIBED AS FOLLOWS:

That part of Lot 2, Block 1, SECOND ADDITION TO THE CITY OF ARTHUR, according to the recorded plat thereof on file and of record in the office of the Recorder in Cass County, North Dakota, described as follows:

Beginning at a found iron monument which designates the northwest corner of said Lot 2; thence South 89 degrees 59 minutes 20 seconds East on a record bearing along the north line of said Lot 2 for a distance of 343.03 feet to a found iron monument at the southwesterly corner of Lot 1, Block 3, SMOKING TREE ADDITION, according to the recorded plat thereof on file and of record in the office of said Recorder; thence South 44 degrees 01 minute 03 seconds West for a distance of 152.93 feet to a found iron monument at the northwest corner of Lot 3, Block 2 said SMOKING TREE ADDITION, said point also being on the south line of said Lot 2; thence North 89 degrees 59 minutes 20 seconds West along the south line of said Lot 2 for a distance of 235.11 feet to a found iron monument at the southwest corner of said Lot 2; thence North 00 degrees 51 minutes 31 seconds West along the west line of said Lot 2 for a distance of 110.01 feet to the point of beginning.

Said tract contains 31,798 square feet, more or less, and is subject to all easements, restrictions, reservations and rights of way of record, if any.




