

TOWNSHIP 139 N RANGE 49 W DESCRIBED AS FOLLOWS:

### DESCRIPTION

COMMENCING AT THE NORTHEAST CORNER OF THE NORTHEAST QUARTER (NE 1/4) OF SECTION FIVE (5), TOWNSHIP ONE HUNDRED THIRTY NINE (139) NORTH, RANGE FORTY NINE (49) WEST;

THENCE WEST ALONG THE NORTH LINE OF SAID SECTION FIVE (5) FOR A DISTANCE OF ONE THOUSAND TWO HUNDRED THIRTY TWO AND FOUR TENTHS (1,232.40) FEET TO THE POINT OF BEGINNING;

THENCE SOUTH PARALLEL WITH THE EAST LINE OF SAID SECTION FIVE (5) FOR A DISTANCE OF ONE THOUSAND SIX HUNDRED SEVENTY ONE AND TWO TENTHS (1,671.20) FEET TO A LINE PARALLEL WITH AND EIGHT HUNDRED SIXTY AND FOUR TENTHS (860.40) FEET NORTH OF THE SOUTH LINE OF SAID NORTHEAST QUARTER (NE 1/4).

THENCE WEST ALONG SAID LINE PARALLEL WITH THE SOUTH LINE OF SAID NORTHEAST QUARTER (NE 1/4) FOR A DISTANCE OF SIX HUNDRED FIFTY (650.00) ;

THENCE NORTH PARRALLEL WITH THE EAST LINE OF SAID SECTION FIVE (5) FOR A DISTANCE OF ONE THOUSAND SIX HUNDRED SEVENTY FOUR AND NINETY ONE HUNDREDTHS (1,674.91) FEET TO A POINT ON THE NORTH LINE OF SAID SECTION FIVE (5);

THENCE EAST ALONG THE NORTH LINE OF SAID SECTION FIVE (5) FOR A DISTANCE OF SIX HUNDRED FIFTY (650.00) FEET TO THE POINT OF BEGINNING.




