


AUDITORS LOT NO. 1

BEGINNING AT THE SOUTHWEST CORNER OF SAID SECTION TWENTY TWO (22);  
THENCE NORTH ALONG THE WEST LINE OF SAID SECTION FOR A DISTANCE OF TWO HUNDRED TEN (210.00) FEET;  
THENCE EAST PARALLEL TO THE SOUTH LINE OF SAID SECTION FOR A DISTANCE OF THREE HUNDRED TEN (310.00) FEET;




