

LOT NUMBER 4 OF SW 1/4 SECTION 5
 TOWNSHIP 139 N RANGE 49 W DESCRIBED AS FOLLOWS:

A PART OF THE SOUTHWEST QUARTER (SW 1/4) OF SECTION FIVE (5), TOWNSHIP ONE HUNDRED THIRTY NINE (139) NORTH, RANGE FORTY NINE (49) WEST, CASS COUNTY, NORTH DAKOTA DESCRIBED BY METES AND BOUNDS AS FOLLOWS:
 BEGINNING AT A POINT ON THE WEST RIGHT-OF-WAY LINE OF CASS COUNTY HIGHWAY #17 TWO HUNDRED TWENTY (220.00) FEET SOUTH OF THE INTERSECTION OF THE SOUTH RIGHT-OF-WAY LINE OF THE BURLINGTON NORTHERN RAILWAY COMPANY (FORMERLY NORTHERN PACIFIC COMPANY) AND THE WEST RIGHT-OF-WAY LINE OF CASS COUNTY HIGHWAY #17 AS THE SAME IS NOW LOCATED;
 THENCE IN A NORTHWESTERLY DIRECTION AND PARALLEL TO THE SOUTH RIGHT-OF-WAY LINE OF SAID RAILWAY A DISTANCE OF TWO HUNDRED (200.00) FEET;
 THENCE DUE SOUTH A DISTANCE OF THREE HUNDRED FIFTY (350) FEET, MORE OR LESS, TO THE CENTERLINE OF THE SHEYENNE RIVER;
 THENCE IN AN EASTERLY DIRECTION ALONG THE CENTERLINE OF SAID RIVER TO A POINT DUE WEST OF A POINT ON THE WEST SIDE OF CASS COUNTY HIGHWAY #17 THAT IS THREE HUNDRED SEVENTY (370.00) FEET SOUTH OF THE POINT OF BEGINNING;
 THENCE EAST ON THE WEST RIGHT-OF-WAY LINE OF CASS COUNTY HIGHWAY #17;
 THENCE NORTH ALONG THE WEST LINE OF CASS COUNTY HIGHWAY #17 A DISTANCE OF THREE HUNDRED SEVENTY (370.00) FEET TO THE POINT OF BEGINNING.






