

A TRACT OF LAND IN THE NORTHWEST QUARTER (NW 1/4) OF SECTION EIGHTEEN (18), TOWNSHIP ONE HUNDRED THIRTY EIGHT (138) NORTH, RANGE FIFTY ONE (51) WEST, CASS COUNTY, NORTH DAKOTA DESCRIBED AS FOLLOWS:
 BEGINNING AT THE NORTHEAST CORNER OF SAID NORTHWEST QUARTER (NW 1/4);
 THENCE WEST ALONG THE NORTH LINE OF SAID SECTION EIGHTEEN (18) FOR A DISTANCE OF NINE HUNDRED FIFTY (950.00) FEET;
 THENCE SOUTH PARALLEL WITH THE EAST LINE OF SAID NORTHWEST QUARTER (NW 1/4) FOR A DISTANCE OF TWO HUNDRED FIFTY (250) FEET, MORE OR LESS, TO THE CENTERLINE OF THE MAPLE RIVER;
 THENCE EASTERLY ALONG SAID RIVER CENTERLINE TO THE EAST LINE OF SAID NORTHWEST QUARTER (NW 1/4);






