

 TOWNSHIP 137 NORTH RANGE 50 WEST DESCRIBED AS FOLLOWS:

Beginning at a point 300 feet East and 380 feet South of the Southwest corner of Block Four (4) of Swenson's Addition to the City of Kindred, thence West to a point 80 feet East of the Southeast corner of Lot One (1), Block Two (2), Swenson's Second Addition to the City of Kindred, a distance of 300 feet, more or less, thence South to the South line of the Southeast Quarter (SE $\frac{1}{4}$) of Section Twenty-nine (29), Township One Hundred Thirty-seven (137), Range Fifty (50), Cass County, North Dakota, a distance of 151 feet, more or less, thence East on the South line of said Southeast Quarter (SE $\frac{1}{4}$) to a point directly South of the point of beginning, a distance of 300 feet, more or less, and thence North to point of beginning a distance of 151 feet, more or less.




