

DESCRIPTION

THAT PART OF THE SOUTHWEST QUARTER (SW 1/4) OF SECTION THIRTY SIX (36), TOWNSHIP ONE HUNDRED THIRTY EIGHT (138) NORTH, RANGE FIFTY (50) WEST OF THE FIFTH PRINCIPAL MERIDIAN, CASS COUNTY, NORTH DAKOTA DESCRIBED AS FOLLOWS:
 BEGINNING AT THE SOUTHWEST CORNER OF SAID SECTION THIRTY SIX (36);
 THENCE NORTH ALONG THE WEST LINE OF SAID SECTION THIRTY SIX (36) FOR A DISTANCE OF SIX HUNDRED SEVENTY (670.00) FEET;
 THENCE EAST PARALLEL TO THE SOUTH LINE OF SAID SECTION THIRTY SIX (36) FOR A DISTANCE OF SEVEN HUNDRED THIRTY (730.00) FEET, MORE OR LESS, TO THE CENTERLINE OF THE SHYENNE RIVER;
 THENCE SOUTHWESTERLY AND SOUTHERLY UPSTREAM ALONG SAID RIVER CENTERLINE TO THE SOUTH LINE OF SAID SECTION THIRTY SIX (36);




