


PLAT OF

LOT NUMBER 2 OF THE N.E. 1/4 S.E. 1/4 SECTION 11 TOWNSHIP 139 NORTH RANGE 49 WEST DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE 1/4 SE 1/4) OF SECTION ELEVEN (11), TOWNSHIP ONE HUNDRED THIRTY NINE (139) NORTH, RANGE FORTY NINE (49) WEST, CASS COUNTY, NORTH DAKOTA;

THENCE EAST ALONG THE NORTH LINE OF SAID NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE 1/4 SE 1/4) FOR A DISTANCE OF ONE HUNDRED NINETY (190.00) FEET TO THE POINT OF BEGINNING;

THENCE CONTINUE EAST ALONG SAID NORTH LINE OF SAID NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE 1/4 SE 1/4) FOR A DISTANCE OF THREE HUNDRED FORTY THREE AND NINETY SIX HUNDREDTHS (343.96) FEET;

THENCE SOUTH PARALLEL TO THE EAST LINE OF SAID NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE 1/4 SE 1/4) FOR A DISTANCE OF THREE HUNDRED SIXTY SEVEN (367.00) FEET;

THENCE WEST PARALLEL TO THE NORTH LINE OF SAID NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE 1/4 SE 1/4) FOR A DISTANCE OF THREE HUNDRED FORTY FOUR AND FORTY SIX HUNDREDTHS (344.46) FEET;

THENCE NORTH PARALLEL TO THE WEST LINE OF SAID NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE 1/4 SE 1/4) FOR A DISTANCE OF THREE HUNDRED SIXTY SEVEN (367.00) FEET TO THE POINT OF BEGINNING.




