

A TRACT OF LAND IN THE NORTHWEST QUARTER (NW 1/4) OF SECTION TWO (2), TOWNSHIP ONE HUNDRED THIRTY NINE (139) NORTH, RANGE FORTY NINE (49) WEST, CASS COUNTY, NORTH DAKOTA DESCRIBED AS FOLLOWS:
 COMMENCING AT THE CENTER OF SAID SECTION TWO (2);
 THENCE N 00°05'30" E (ASSUMED BEARING) AND ALONG THE EAST LINE OF SAID NORTHWEST QUARTER (NW 1/4) FOR A DISTANCE OF ONE THOUSAND ONE HUNDRED THIRTY SEVEN AND THREE TENTHS (1137.30) FEET;
 THENCE N 88°09'40" W FOR A DISTANCE OF THIRTY SEVEN AND FIFTY TWO HUNDREDTHS (37.52) FEET TO THE WEST RIGHT-OF-WAY LINE OF CASS COUNTY DRAIN NO. 10 AND THE POINT OF BEGINNING;
 THENCE CONTINUING N 88°09'40" W FOR A DISTANCE OF FOUR HUNDRED FIFTY NINE AND TWENTY EIGHT HUNDREDTHS (459.28) FEET;
 THENCE N 00°00'00" E FOR A DISTANCE OF ONE HUNDRED EIGHTY NINE AND SEVENTY TWO HUNDREDTHS (189.72) FEET TO THE SOUTH LINE OF MEADOW PARK ADDITION TO THE CITY OF FARGO, CASS COUNTY, NORTH DAKOTA;
 THENCE S 88°09'40" E ALONG THE SOUTH LINE AND SOUTH LINE EXTENDED OF SAID MEADOW PARK ADDITION FOR A DISTANCE OF FOUR HUNDRED FIFTY NINE AND FIFTY EIGHT HUNDREDTHS (459.58) FEET TO THE WEST RIGHT-OF-WAY LINE OF CASS COUNTY DRAIN NO. 10;
