

 TOWNSHIP 137 N. RANGE 50 W. DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT WHICH IS 577.5 FEET WEST OF AND 780 FEET SOUTH OF THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 20, TOWNSHIP 137 NORTH, RANGE 50 WEST, NORMANNA TOWNSHIP, CASS COUNTY, NORTH DAKOTA AND SAID POINT IS THE TRUE POINT OF BEGINNING OF AUDITORS LOT NO. 4 HEREINAFTER DESCRIBED; THENCE SOUTH AND PARALLEL TO THE EAST LINE OF SAID NORTHWEST QUARTER FOR A DISTANCE OF 540 FEET; THENCE WEST AND PARALLEL TO THE NORTH LINE OF SAID NORTHWEST QUARTER FOR A DISTANCE OF 214.5 FEET; THENCE NORTH AND PARALLEL TO SAID EAST LINE FOR A DISTANCE OF 540 FEET; THENCE EAST AND PARALLEL TO SAID NORTH SECTION LINE FOR A DISTANCE OF 214.5 FEET TO THE TRUE POINT OF BEGINNING.
