

TOWNSHIP 138 North RANGE 48 West DESCRIBED AS FOLLOWS:

Beginning at the Northwest Corner of Government Lot 2 of Section 31, Township 138 North, Range 48 West of the Fifth Principal Meridian, Cass County, North Dakota; thence North 89°59'44" East along the North Line of said Government Lot 2 a distance of 325.99 feet; thence South 00°06'37" West a distance of 246.48 feet; thence South 66°40'29" West a distance of 123.28 feet; thence South 58°40'29" West a distance of 127.00 feet; thence South 36°29'17" West a distance of 175.60 feet, more or less, to a Point of Intersection with the North-South Quarter Line in said Section 31; thence North 00°04'12" East along said North-South Quarter Line a distance of 503.06 feet, more or less, to the Point of Beginning. Said tract of land contains 2.559 acres, more or less.
