


PLAT OF

A TRACT OF LAND LYING IN THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER (NW 1/4 NW 1/4) OF SECTION EIGHTEEN (18), TOWNSHIP ONE HUNDRED THIRTY NINE (139) NORTH, RANGE FORTY NINE (49) WEST OF THE FIFTH PRINCIPAL MERIDIAN, CASS COUNTY, NORTH DAKOTA DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE NORTH LINE OF SAID SECTION EIGHTEEN (18); SAID POINT BEING ONE HUNDRED TWENTY FIVE AND FIVE TENTHS (125.5) FEET EAST OF THE NORTHWEST CORNER; THENCE S 89° 58' 50" E ALONG THE NORTH LINE OF SAID SECTION EIGHTEEN (18) FOR A DISTANCE OF THREE HUNDRED THREE (303) FEET; THENCE S 0° E PARALLEL TO THE WEST LINE OF SAID SECTION FOR A DISTANCE OF TWO HUNDRED (200) FEET; THENCE N 89° 58' 50" W PARALLEL TO THE NORTH LINE OF SAID SECTION FOR A DISTANCE OF TWO HUNDRED EIGHTY THREE AND TWENTY SEVEN HUNDREDTHS (283.27) FEET; THENCE N 47° 04' 00" W PARALLEL TO THE NORTH RIGHT-OF-WAY OF INTERSTATE HIGHWAY NO. 94 FOR A DISTANCE OF TWENTY SIX AND NINETY FIVE HUNDREDTHS (26.95) FEET; THENCE N 0° E PARALLEL TO THE WEST LINE OF SAID SECTION FOR A DISTANCE OF ONE HUNDRED EIGHTY ONE AND SIXTY FIVE HUNDREDTHS (181.65) FEET TO THE POINT OF BEGINNING. 
