


# PLAT OF

THAT PART OF LOT FOURTEEN (14) IN BLOCK THREE (3) OF LEPIRD'S SUBDIVISION OF A PART OF THE SOUTHEAST QUARTER (SE 1/4) OF SECTION SEVEN (7), TOWNSHIP ONE HUNDRED THIRTY NINE (139) NORTH, RANGE FORTY NINE (49) WEST OF THE FIFTH PRINCIPAL MERIDIAN, CASS COUNTY, NORTH DAKOTA LYING EAST OF THE SHEYENNE RIVER DESCRIBED AS FOLLOWS:  
COMMENCING AT THE NORTHEAST CORNER OF SAID LOT FOURTEEN (14); THENCE WEST ALONG THE NORTH LINE OF SAID LOT FOURTEEN (14) FOR A DISTANCE OF ONE HUNDRED TWENTY SEVEN (127.0) FEET TO THE POINT OF BEGINNING; THENCE SOUTH PARALLEL TO THE WEST RIGHT-OF-WAY OF SHEYENNE STREET IN THE CITY OF WEST FARGO FOR A DISTANCE OF NINETY FIVE (95.0) FEET; THENCE WEST PARALLEL TO THE NORTH LINE OF SAID LOT FOURTEEN (14) FOR A DISTANCE OF FORTY FIVE (45.0) FEET; THENCE SOUTH PARALLEL TO THE WEST RIGHT-OF-WAY OF SAID SHEYENNE STREET IN THE CITY OF WEST FARGO FOR A DISTANCE OF SIXTEEN (16.0) FEET; THENCE WEST PARALLEL TO THE NORTH LINE OF SAID LOT FOURTEEN (14) FOR A DISTANCE OF EIGHTY (80.0) FEET; THENCE NORTH PARALLEL TO THE WEST RIGHT-OF-WAY OF SAID SHEYENNE STREET FOR A DISTANCE OF ONE HUNDRED ELEVEN (111.0) FEET TO A POINT ON THE NORTH LINE OF SAID LOT FOURTEEN (14); THENCE EAST ALONG THE NORTH LINE OF SAID LOT FOURTEEN (14) FOR A DISTANCE OF ONE HUNDRED TWENTY FIVE (125.0) FEET TO THE POINT OF BEGINNING.



