

COMMENCING AT A POINT WHICH IS 720 FEET EAST OF THE SOUTHWEST CORNER OF THE THE SOUTHWEST QUARTER OF SECTION 8, TOWNSHIP 137 NORTH, RANGE 49 WEST, PLEASANT TOWNSHIP, CASS COUNTY, NORTH DAKOTA, AND SAID POINT IS THE TRUE POINT OF BEGINNING OF AUDITORS LOT 2 HEREINAFTER DESCRIBED; THENCE EAST AND ALONG THE SOUTH SECTION LINE OF SAID SOUTHWEST QUARTER FOR A DISTANCE OF 380 FEET; THENCE NORTH AND PARALLEL TO THE WEST SECTION LINE OF SAID SOUTHWEST QUARTER FOR A DISTANCE OF 280 FEET; THENCE WEST AND PARALLEL TO SAID SOUTH SECTION LINE FOR A DISTANCE OF 380 FEET; THENCE SOUTH AND PARALLEL TO SAID WEST SECTION LINE FOR A DISTANCE OF 280 FEET TO THE POINT OF BEGINNING.
