

A CIRCULAR TRACT OF LAND LYING IN AUDITOR'S LOT ONE (1) OF THE SOUTHWEST QUARTER (SW 1/4) OF SECTION TWENTY EIGHT (28) TOWNSHIP ONE HUNDRED THIRTY SEVEN (137) NORTH, RANGE FIFTY TWO (52) WEST, CASS COUNTY, NORTH DAKOTA DESCRIBED AS FOLLOWS:
COMMENCING AT THE NORTHEAST CORNER OF AUDITOR'S LOT ONE (1) OF SAID SOUTHWEST QUARTER (SW 1/4); THENCE S 89° 56' 49" W ALONG THE NORTH LINE OF SAID AUDITOR'S LOT ONE (1) FOR A DISTANCE OF SIX HUNDRED FIFTY NINE AND FIFTY HUNDREDTHS (659.50) FEET; THENCE S 01° 54' 32" E FOR A DISTANCE OF ONE HUNDRED SIXTY FIVE AND TWENTY TWO HUNDREDTHS (165.22) FEET TO THE RADIUS POINT OF SAID CIRCULAR TRACT; THENCE CONTINUE S 01° 54' 32" E FOR A DISTANCE OF TWENTY SEVEN (27.00) FEET TO THE POINT OF BEGINNING; THENCE ALONG A CURVE TO THE RIGHT ABOUT SAID RADIUS POINT ($\Delta = 360^\circ$, R - 27.00') FOR AN ARC DISTANCE OF ONE HUNDRED SIXTY NINE AND SIXTY FIVE HUNDREDTHS (169.65) FEET, RETURNING TO THE POINT OF BEGINNING.


