

 TOWNSHIP 138 N RANGE 49 W DESCRIBED AS FOLLOWS:

LEGAL DESCRIPTION

A tract of land situated in a portion of the Northeast Quarter of Section 11, Township 138 North, Range 49 West, of the Fifth Principal Meridian, Cass County, North Dakota, and being more fully described as follows:

Commencing at the North One Quarter Corner of said Section 11, said point being the point of beginning, thence South 90 degrees 00 minutes 00 seconds East on the north line of said Section 11 for a distance of 42.13 feet; thence South 01 degrees 22 minutes 10 seconds East parallel with the North-South Quarter line of said Section 11 for a distance of 418.43 feet; thence South 90 degrees 00 minutes 00 seconds East parallel with the north line of said Section 11 for a distance of 483.65 feet; thence North 01 degrees 22 minutes 10 seconds West parallel with the North-South Quarter line of said Section 11 for a distance of 418.43 feet to a point on the north line of said Section 11; thence South 90 degrees 00 minutes 00 seconds East on the north line of said Section 11 for a distance of 145.65 feet; thence South 01 degrees 27 minutes 13 seconds East parallel with the east line of said Section 11 for a distance of 2651.11 feet to a point on the East-West Quarter line of said Section 11; thence South 89 degrees 53 minutes 07 seconds West on the East-West Quarter line of said Section 11 for a distance of 675.30 feet to the Center of Section 11; thence North 01 degrees 22 minutes 10 seconds West on the North-South Quarter line of said Section 11 for a distance of 2652.37 feet to the point of beginning, EXCEPT 1.20 acres as described in a warranty deed on file in the Cass County Register of Deeds office in Book 399 of Deeds page 404. Said tract contains 35.14 acres more or less, and is subject to all easements of sight and record.




