


BEGINNING AT THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF SAID SOUTHEAST QUARTER;

THENCE SOUTH ALONG THE WEST LINE OF SAID WESTVIEW FIRST ADDITION TO THE SOUTHWEST CORNER THEREOF, SAID CORNER LYING ON THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SAID SOUTHEAST QUARTER;




