


ORIGINAL TOWNSHIP

THE NORTH THIRTY (30) FEET OF FOURTH AVENUE SOUTH ADJACENT TO THE SOUTH LINE OF BLOCK 34, ORIGINAL TOWNSITE AND THE SOUTH THIRTY (30) FEET OF FOURTH AVENUE SOUTH ADJACENT TO THE NORTH LINE OF BLOCK 35, NORTHERN PACIFIC ADDITION BETWEEN THE WEST LINE OF SEVENTH STREET SOUTH AND THE EAST LINE OF EIGHTH STREET SOUTH ALL LYING WITHIN THE CITY OF FARGO, N. DAK.
