



DESCRIPTION OF AREA TO BE VACATED:

THE NORTH-SOUTH ALLEY IN BLOCK 34 AND ALL THAT PORTION OF THE SAID NORTH-SOUTH ALLEY IN BLOCK 27 LOCATED SOUTH OF 8TH AVENUE NORTH, AS THE SAID AVENUE IS NOW LOCATED, IN BEARDSLEY'S ADDITION TO THE CITY OF FARGO, CASS COUNTY, NORTH DAKOTA, ACCORDING TO THE CERTIFIED PLAT THEREOF, ON FILE AND OF RECORD IN THE OFFICE OF THE REGISTER OF DEEDS, WHICH SAID ALLEY IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF LOT 6, BLOCK 34 OF BEARDSLEY'S ADDITION TO THE CITY OF FARGO; THENCE NORTH ALONG THE EAST EDGE OF SAID ALLEY AS NOW PLATTED TO THE SOUTH LINE OF 8TH AVENUE NORTH IN THE CITY OF FARGO, AS NOW LOCATED; THENCE WEST, A DISTANCE OF 20 FEET TO THE WEST EDGE OF SAID ALLEY; THENCE SOUTH ALONG THE WEST EDGE OF SAID ALLEY TO THE SOUTHEAST CORNER OF LOT 13, BLOCK 34 OF BEARDSLEY'S ADDITION TO THE CITY OF FARGO, CASS COUNTY, NORTH DAKOTA, ACCORDING TO THE CERTIFIED PLAT THEREOF; THENCE EAST, A DISTANCE OF 20 FEET TO THE POINT OF BEGINNING, ALL AS SHOWN ON THE ATTACHED PLAT.
