

THAT PART OF McDERMOTT'S SECOND SUBDIVISION OF PART OF THE NORTHEAST QUARTER (NE1/4) OF SECTION EIGHT (8), TOWNSHIP ONE HUNDRED THIRTY-NINE (139) NORTH, RANGE FORTY-NINE (49), WEST OF THE FIFTH PRINCIPAL MERIDIAN, CASS COUNTY, NORTH DAKOTA, AND THAT PART OF MEYER'S FIRST ADDITION TO THE CITY OF SOUTHWEST FARGO, CASS COUNTY, NORTH DAKOTA, BEING BOUND ON THE NORTH BY BLOCK TWO (2) OF SAID McDERMOTT'S SECOND SUBDIVISION, BEING BOUNDED ON THE EAST BY THE EXTENDED EAST BOUNDARY LINE OF BLOCK TWO (2) OF SAID McDERMOTT'S SECOND SUBDIVISION, BEING BOUNDED ON THE WEST BY THE EXTENDED WEST BOUNDARY LINE OF BLOCK TWO (2) OF SAID McDERMOTT'S SECOND SUBDIVISION, AND BEING BOUNDED ON THE SOUTH BY THE NORTH BOUNDARY LINE OF BLOCK TWO (2) OF SAID MEYER'S FIRST ADDITION.
