



PLAT OF
ANNA L. HOLES ADDITION

OWNERS CERTIFICATE

KNOW ALL MEN BY THESE PRESENTS: That Anna L. Holes, and Russell Hurd and Helen Hurd, husband and wife, are the owners and proprietors of that part of Government Lot 3, Section 32, Township 140 North, Range 48 West, of the Fifth Principal Meridian, Cass County, North Dakota, described as follows:

Beginning at the Southwest corner of said Section 32; thence North 00°00'00" East (assumed bearing) along the West line of said Section 32 for a distance of 685.85 feet; thence North 90°00'00" East along the South line of W. L. Zitzow's First Addition to the City of Fargo, and Westerly extension thereof, for a distance of 190.00 feet to the Southeast corner of said W. L. Zitzow's First Addition; thence South 00°00'00" East for a distance of 683.71 feet to a point on the South line of said Section 32; thence South 89°21'20" West along the South line of said Section 32 for a distance of 190.01 feet to the point of beginning.

Commencing at the Southwest corner of said Section 32; thence North 00°00'00" East (assumed bearing) along the West line of said Section 32 for a distance of 1085.85 feet to the TRUE POINT OF BEGINNING; thence North 90°00'00" East along the North line of W. L. Zitzow's First Addition to the City of Fargo, and Westerly extension thereof, for a distance of 190.00 feet to the Northeast corner of said W. L. Zitzow's First Addition; thence North 00°00'00" West for a distance of 9.57 feet; thence North 55°25'04" West for a distance of 182.19 feet; thence South 90°00'00" West for a distance of 40.00 feet to a point on the West line of said Section 32; thence South 00°00'00" West along the West line of said Section 32 for a distance of 112.98 feet to the TRUE POINT OF BEGINNING.
