BEGINNING AT A POINT 1403 FEET WEST OF AND 40 FEET SOUTH OF THE NORTHEAST CORNER OF THE SOUTHEAST 1/4 OF SECTION 2, TOWNSHIP 139 NORTH, RANGE 49 WEST; THENCE SOUTH AND PARALLEL TO THE WEST LINE OF 27TH STREET NORTH, A DISTANCE OF 505.29 FEET; THENCE WEST AND PARALLEL TO THE SOUTH LINE OF 7TH AVENUE NORTH, A DISTANCE OF 67 FEET; THENCE NORTH AND PARALLEL TO THE WEST LINE OF SAID 27TH STREET NORTH, A DISTANCE OF 505.29 FEET; THENCE EAST 67 FEET TO THE POINT OF BEGINNING.
