DESCRIPTION OF AREA VACATED

A PORTION OF 4th AVENUE SOUTH LYING NORTH OF LOTS 9, 10, AND 11, BLOCK 9, ARNESON ADDITION TO THE CITY OF FARGO, CASS COUNTY, NORTH DAKOTA OR MORE FULLY DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF SAID LOT 11, BLOCK 9 THENCE NORTHERLY AND ALONG THE EAST LINE OF SAID LOT 11 EXTENDED A DISTANCE OF TWENTY ONE AND NINETEEN HUNDREDTHS (21.19') FEET; THENCE WESTERLY AND PARALLEL TO THE NORTH LINE OF SAID LOTS 9, 10 AND 11 BLOCK 9 A DISTANCE OF ONE HUNDRED FORTY THREE AND NINETY FIVE HUNDREDTHS (143.95') FEET MORE OR LESS TO THE NORTHWEST CORNER OF SAID LOT 9, BLOCK 9; THENCE SOUTHEASTERLY AND EASTERLY ALONG THE NORTH LINE OF SAID LOTS 9, 10, AND 11 TO THE NORTHEAST CORNER OF SAID LOT 11 THE TRUE POINT OF BEGINNING.
